Constitution, By-Laws & Rules

Revised June 2024

Constitution

Article I.

Name

- Section 1. This organization shall be known and designated as the Allied Sportsmen of Western New York, Inc.

Article II.

Purposes of Organization

- Section 1. Good Sportsmanship.
- Section 2. To create, cultivate and sponsor among all people a respect for the Fish and Game laws and regulations of the Conservation Department of the State of New York pertaining thereto.
- Section 3. To sponsor legislation that will tend to preserve fish, game and natural resources that will be beneficial to all persons interested in angling, hunting or conservation for recreational purposes.
- Section 4. To actively and aggressively seek and repeal of any law, ruling or regulation that may be discriminatory, unfair or unjust in so far as such provision affects the preservation or propagation of fish and game life or which may unduly or unnecessarily restrict the privilege of taking such fish or game, but bringing such facts to the attention of the proper authorities in as forcible a manner as possible.
- Section 5. It shall always be the primary aim and purpose of this organization to attempt to improve the hunting and fishing conditions for sportsmen.

Article III.

Membership

- Section 1. Any citizen of the United States, male or female, 12 years of age or upwards, who have not been convicted of a major conservation law violation and who subscribes to and complies with the rules and regulations of this organization, as set forth in its constitution and By-Laws, shall be eligible for membership providing the vacancies exist on the membership rolls.
- Section 2. No person under 18 years of age is eligible to vote.
- Section 3. The membership role of Allied Sportsmen of Western New York, Inc. may be closed by vote of 3/4 of the members attending a regularly conducted meeting,

providing the quorum is present. The membership roll may be opened by a vote of 3/4ths of the members present at a regularly conducted meeting, providing a quorum is present.

Section 4. Registration fees and conditions covering membership shall be provided for in the By-Laws.

Article IV. Officers

Section 1. The officers of Allied Sportsmen of Western New York, Inc. shall be at least 21 years of age; shall consist of President, Vice-President, Treasurer, Recording Secretary and Financial Secretary. All officers must be able to sign New York State Liquor Authority forms. The President shall appoint the Vice-President, Treasurer, Recording Secretary and Financial Secretary. The Board of Directors shall approve all.

Article V. Powers and Duties of Officers

Section 1. The President of this organization shall function as the chief executive officer and shall preside at all meetings of the club when in general or special session.

Section 2. The Vice-President shall preside at all meetings of the club when in general or special session in the absence of the President or when called upon to do so by the president.

Section 3. The Treasurer shall keep an accurate account of the funds of the club and give a detailed account of the financial condition of the club to the Executive Board once each month at the regular Board meeting. It shall be his or her duty to submit monthly reports of the financial condition of the club at the regular monthly meetings. The Treasurer shall be bonded in any amount as may be deemed adequate by the Executive Board. He or she shall give proper receipt to the Financial Secretary for all monies received from him. No one shall alter the Treasurer's books without his or her knowledge. Disputes are to be settled by the Executive Board.

Section 4. The Financial Secretary shall receive all monies due to the club; shall issue a proper receipt therefore and turn over such monies to the Treasure at the close of each meeting.

Section 5. The Recording Secretary shall keep accurate minutes of each meeting of the club and also each meeting of the Executive Board according to Roberts Rules of Order. The Recording Secretary shall answer all correspondence of the Club as and when directed to do so by the Club. It shall be the duty of the Recording Secretary to possess at each meeting of the club, as well as meetings of the Executive Board, the Constitution and By-Laws of the organization, as well as any amendments and changes in them if there be any.

- The Recording Secretary shall have custody of these instruments, as well as any charter that may be issued by the State of New York.
- Section 6. The Membership Chairman shall receive all new membership applications, make a proper investigation of each applicant, and submit appropriate recommendations to the Executive Board and the general membership. He shall receive all dues and assessments and turn over an accurate accounting to the Financial Secretary. He must keep an accurate record of all members in good standing.
- Section 7. Upon approval of the Executive Board, any officer may request to delegate a portion of his/her responsibility to an assistant.

Article VI.

Election of Officers and their Terms of Office

- Section 1. By February, each year the Board of Directors shall designate a Nominating Committee of 3. The Board shall announce the Nominating Committee members. The Nominating Committee shall elect its own Chairperson from among its members.
- Section 1.0 The Nominating Committee shall prepare a written report of nominees for the Board. The nominees should come from members of the club in good standing. The list of nominees should be delivered no fewer than 30 days nor more than 45 days prior to the election date. The Nominating Committee shall produce a mailing of the nominees to each voting member and post copies on the club bulletin boards by the March general meeting. Nominations may be made from the floor at the March general meeting. The nominees for office should be members in good standing for at least one year. If an individual has been a member for less than a year but has the best interest of the club in mind, that individual may be placed in nomination by a majority vote to waive the one-year membership requirements.
- Section 1.1 After the written report is presented to the voting members, further nominations may be made by petition of voting members addressed to the Chairperson of the Nominating Committee, containing signatures of 25 or more voting members. The petition should include a request that an eligible member or members named be nominated in addition to the nominations previously made. Such petition or petitions shall be received by the Chairperson of the Nominating Committee at least 20 days prior to the election. Such additional nominations must be posted on the club bulletin boards.
- Section 1.2 Once the election is held and all eleven seats on the board are filled, any unexpired term shall be filled in the descending order of time left in term by candidates in descending order of the number of votes received.
- Section 1.3 Should a problem arise, the Nominating Committee must contact a Board member so that any request for change may be approved by the Executive Board. There shall be no deviations in ballots after Board approval has been granted. Ballots will be available during the general meeting in April and the

Sunday proceeding from 10 AM to 2 PM. Each voter must present picture ID or a membership card which will be cross referenced with the official list of members in good standing.

- Section 1.4 The Board of Tellers (vote counters), shall consist of at least 3 members. None of whom are candidates for any office.
- Section 1.5 Printed election ballot shall contain the names of each candidate for office, together with the necessary instructions for marking. The ballot shall also contain a space for write in candidates and all incumbents on the ballots will be marked with an asterisk. Ballots shall be presented to the Board for approval prior to final printing.
- Section 1.6 All officers, Directors and committee heads shall upon the expiration of their terms, suspension, or expulsion within 14 days, deliver to their successors, or somebody in authority, all books, papers, or materials belonging to the club which may be in their possession.
- Section 2. The annual election of directors shall be held at the regular meeting in the month of April to replace directors who have left, who have finished their term, or have been replaced by the Board. The Board has the discretion to change the date of the election if for good reason.
- Section 3. The installation of officers and directors shall be held at the regular meeting in the month of May each year unless changed for good reason by the Board.
- Section 4. All directors shall be elected for a 3-year term. The 11 directors will at their first meeting, elect their President to lead the Board for a 2-year term. The President shall choose who he would like to serve as his Vice-President who will serve the President for 1 year. All directors must have been members of the club for at least 1 year and must be 21 years of age and must comply with the New York State Liquor Authority rules.
- Section 5. Executive Board vacancies created for any reason will be filled by candidates:
- a. From the ballots of the year in which the vacancy occurred.
 - b. If the vacancy occurred before March of that year, such vacancies will be filled with the individual with the highest number of votes who did not receive a Board seat at the time the election was held.
 - c. Upon the vacancy of multiple terms, the remainder of that term will be offered to directors of a 1-year term in descending order. That 1-year vacancy will be filled as above.
 - d. Ties to fill any vacancy shall be decided by the flip of a coin.
- Section 6. Board members are elected to serve for 3 years. If a Board member wishes to run for an additional 3-year term he or she may do so after running again and being voted into office for a second 3-year term by the membership. For a person to run for a second 2-year term as President he/she will have to take a year off and then run again for the Board; be re-elected to the Board by the membership and then be elected again as President by the new Board.

Article VII.

Creation of Affiliated Bodies

- Section 1. A group of 10 or more persons in any locality that may be interested in and in sympathy with the activities of Allied Sportsmen of Western New York, Inc. may, by submitting an application in writing to the Club and by properly qualifying, receive authority from the Club to organize an affiliated organization to be known as a branch organization of the Allied Sportsmen of Western New York, Inc.
- Section 2. When the club receives any such application it shall be submitted to the Executive Board for investigation and their determination, no affiliated organization shall be created or authorized without the approval of the Executive Board.
- Section 3. Any such branch or affiliated organization shall be governed by the Executive Board in accordance with the constitution and By-Laws of the Allied Sportsmen of Western New York, Inc. as to the number of meetings, what shall constitute a quorum, the name of the branch, etc.

Article VIII.

Alliance of Existing Groups

- Section 1. The Executive Board shall have the power to authorize the President of the Board, by a majority vote, to create and appoint a committee to be known as the Alliance Committee whose duty and purpose shall be to devise ways and means of creating a practical plan for the affiliation of any existing organization of a similar nature with the Allied Sportsmen of Western New York, Inc.
- Section 2. It shall be the duty of the Alliance Committee to formulate plans for any proposed affiliation especially as to fees, charges, and dues. Such plans as may be formulated must be approved by a majority vote of the Executive Board before such plans become operative.
- Section 3. It shall be the duty of the Alliance Committee to investigate any proposed affiliation and report in writing on each application to the Executive Board. No club, organization, society, or association shall become affiliated with the Allied Sportsmen of Western New York, Inc., unless approved by a majority vote of the Executive Board.
- Section 4. The Alliance Committee shall consist of not less than 3 nor more than 5 members.

Article IX.

Procedure for Amending Constitution

- Section 1. The provisions of this constitution shall not be changed, altered, or enlarged in any way, shape, or matter unless the following provisions are complied with:
- a. Any proposed change, alteration, or addition must be in writing in the form of a petition which shall be subscribed to by at least 20% of members in good standing and must be submitted to the Recording Secretary at a regular meeting.
 - b. Such a petition shall be drawn in duplicate and contain the proposed amendment in the exact form it is to be added if duly passed.
 - c. The Recording Secretary upon having such proposed amendment properly submitted shall first ascertain from the Membership Chairman, members in good standing, and then the Recording Secretary shall read the proposed amendment to the assembled members, and this shall constitute the first reading. The Recording Secretary shall then submit the duplicate of such proposed amendment to the President of the Executive Board for investigation and consideration by that body.
 - d. The Executive Board upon having such proposed amendment submitted to them, shall make whatever investigation they may deem necessary and give the matter the proper attention and then submit a report of their findings, together with their recommendations, to proposed amendment which was submitted to them. Such report must be in duplicate and must be subscribed to by those members of the Executive Board who are in accordance with the recommendations therein contained, and such report must bear a notation of those members who are opposed to such recommendations.
 - e. At the next regular meeting of the club following the meeting at which such proposed amendment was originally submitted, the Recording Secretary shall again read the proposed amendment, together with the report of the findings and recommendations of the Executive Board. This shall constitute the second reading.
 - f. At the third regular meeting of the club following the meeting at which such proposed amendment was originally submitted, the Recording Secretary shall again read the proposed amendment, together with the report of the Executive Board as submitted at the previous meeting and any further recommendations the Executive Board may see fit and proper to submit. This shall constitute the third reading.
 - g. The President shall then put the proposed amendment before the assembled members for their consideration and their action. If such proposed amendment, when reported upon at the third reading by

the Executive Board, received the approval of that body, then a majority vote of the assembled members shall be enough to pass such proposed amendment and make it part of this Constitution. However, if the Executive Board fails to recommend passage of such proposed amendment it shall then be necessary to have a 3/4ths vote of the assembled members to effect passage of the proposed amendment.

- h. All votes and amendments must be taken by a standing vote, and upon request by any member or any or all the voters may be required to be certified by the Membership Chairman as to their qualifications to cast their votes.
- i. An amendment to this Constitution may not be passed at a special meeting nor may any of the required readings be had at a special meeting.

By-Laws

Chapter I Meetings

- Section 1. The regular meeting of the Allied Sportsmen of Western New York, Inc., shall be held on the second Wednesday of each month at 7:00 PM, provided that when the regular meeting falls on a holiday the President, with the approval of the Executive Board, is vested with the full power to move the regular meeting day if conditions warrant such a move.
- Section 2. Special meetings may be called by the President with the approval of the Executive Board or at the written request of 50 members in good standing, to be held wherever and whenever the President, with the approval of the Executive Board, shall deem necessary, except that no special meeting shall be held on a legal holiday. No lawful action may be taken at a special meeting except on matter or matters contained to the notice. Every reasonable attempt must be made to notify members of a special meeting.
- Section 3. At all meetings, 25 members in good standing shall constitute a quorum for the transaction of business, or a majority of the Officers and Directors.
- Section 4. No one is to be admitted to a regular or special meeting except upon presentation to the Membership Committee Chairman, of a membership card showing the person to be a member in good standing, provided that visitors shall be vouched for if deemed proper by the President.
- Section 5. The Executive Board of the Allied Sportsmen of Western New York, Inc. shall meet at least once a month at a place agreed upon by a majority of the Board. The President of the Board, with the approval of the members of the Board, shall have the power to designate the meeting day. The Executive Board may hold as many meetings, as a majority of the Executive Board may deem necessary. The Executive Board may, by the majority vote, increase the number of required meetings to be held by passing a resolution to that effect at a regular Board meeting.
- Section 6. A majority of the members of the Executive Board shall constitute a quorum of the Board.
- Section 7. In the event of 1 to 3 Board members are lacking to constitute a quorum at a meeting of the Executive Board, the President may designate a club officer or officer's voting privilege, pro-tem to continue its work.

Chapter II Applications for Membership

- Section 1. Applications for membership must be referred to the Membership Chairman at the same meeting at which such applications are received and must be reported on at the next meeting.

- Section 2. All applications for membership must be accompanied by the annual dues and initiation fees, except as provided for in Chapter III, and any other fees and assessments as may be prescribed by the Club from time to time.
- Section 3. All applications referred to the Membership Chairman must, before the meeting is adjourned, be read to the assembled members.
- Section 4. The Membership Chairman must pass all applications and report his actions to the Executive Board at its next regular meeting for final approval before the assembled members of the Club ballot upon candidates at the next regular meeting.
- Section 5. Any person whose application has been rejected may again, after a period of 3 months, apply in person to the Executive Board for re-application. The decision of the Executive Board is final.
- Note:** The only other exception to section 1, 2, 3 and 4 of Chapter II, called Applications for Membership, would be for special membership campaigns.

Chapter III

Revenue

- Section 1. The dues of the Allied Sportsmen of Western New York, Inc. shall be determined by 3 consecutive monthly votes of approval by the general membership, payable in advance, except as provided for in Sections 2, 3, and 4, plus an initiation fee, to be approved by the general membership.
- Section 2. The initiation fee for spouses and children of paid-up members shall be waived, but they shall pay dues as indicated by the current list of membership classifications.
- Initiation: \$100
- Yearly Dues: \$110
- Add spouse and children (to age 22): \$50
- Work hours: 15hrs total per family per year (April-April)
- a. The dues for the spouse of a deceased member shall be at the reduced rate of one-half the regular membership per year, for as long as he/she may desire to continue their membership.
- Section 3. All dues may be prorated at the discretion of the Executive Board.
- Section 4. All revenues received by committees for club activities will be turned over to the Financial Secretary as soon as possible. A committee may spend a maximum of \$75.00 without Board approval in any 30-day period in order to carry on its work. This \$75.00 limit will not apply to normal operating expenses. A receipt for all expenditures must be submitted within 30 days for reimbursement and approval of the Board of Directors. Expenditures over \$75.00 require Board approval.
- Section 5. A drop list will be published with a cut-off date for final dues payment. If dues are not paid by the cut-off date, a new application must be filed with dues and initiation fee, unless application for a waiver has been filed and granted by the Executive Board.

Chapter IV

Committees

- Section 1. The Executive Board shall appoint the following standing committees not later than the regular meeting in the month of June of each year: Archery, Audit, Bar, Buildings, Fund Raising, Grounds, IT Tech, Kitchen, Legislation, Membership, Publicity, Merchandise Sales, Pistol, Publicity, Range Training, Rifle, Safety/Security, Trap.
- Section 2. Should the Executive Board fail to appoint the above committees at or before the June regular meeting of each year, then it shall be the duty of the President to recommend candidates for appointments, which if the Executive Board does not concur with, shall be deemed as legally appointed by majority vote of the members at the next regular general meeting of the Club.
- Section 3. Any member who is not in good standing shall not serve on any committee.
- Section 4. The Audit Committee shall meet monthly to audit the accounts of the Bar, Treasurer, and Financial Secretary and report in full at the next regular meeting. The report must be accepted by a motion by the members at the next regular meeting of the Club.
- Section 5. Special committees may be appointed from time to time as the President may deem necessary; such committees, however, shall not conflict with any standing committees.

Chapter V

Complaints or Grievances

- Section 1. All complaints or grievances of any kind or nature must be made in writing and in duplicate and submitted to the Board, which after consideration and investigation, shall meet in person with both sides present. The Board President shall present the Board recommendations, together with the original complaint for final disposition.
- Section 2. Whenever it is sought to expel or suspend any member, such desire must be submitted in writing and in duplicate to the Board. Such written complaint must contain the reasons for such proposed action. After due investigation and deliberation, the Board shall arrange an in-person meeting, and submit their recommendations in writing, together with the original complaint for final disposition by the Board.
- Section 3. No member shall have a grievance filed against him/her, or be expelled or suspended, without being given an opportunity to answer the charges against him/her. It shall be the duty of the Board to notify and supply, with a copy of the complaint against any member to whom charges are preferred. Such notification must be made by mailing a copy of the charges to the accused member to the address shown on the membership roll of the Club for such a member. The mailing must be sent by registered mail, return receipt

requested. The notice must contain the time and place where such member may appear to answer the charges made against him/her.

Section 4. Any member against whom charges are being preferred may, after the Board has presented their recommendations, by filing a written notice with the Recording Secretary within 10 days from the day he/she is duly notified, demand that he/she be given a hearing before the Executive Board. As per the authority of the general membership, the hearing decision of the Executive Board shall be deemed final and binding. No appeal.

Section 5. If, after due notification, any member against whom charges are preferred, and such member fails to appear at the time and place designated by both parties and the Board, it shall be deemed an admission of the charges.

Chapter VI

Grounds for Suspension or Expulsion

Section 1. Any member who is in arrears in his dues or assessments may be dropped from the membership rolls.

Section 2. Any member who is guilty of unsportsmanlike conduct may be suspended or expelled. The decision of the Executive Board in such cases shall be final. No appeal

Chapter VII

Membership Rolls

Section 1. It shall be the duty of the Membership Chairman to keep intact the membership roll of Allied Sportsmen of Western New York, Inc. Should release of the membership roll become necessary for any legitimate Club purpose, due authorization may be secured from the Executive Board.

Chapter VIII

Official Publicity

Section 1. No member shall issue any statement or engage in any activities to represent Allied Sportsmen of Western New York, Inc., without consent or approval of the Executive Board or the Publicity Committee.

Chapter IX

Penalties

- Section 1. Any violation of the provisions of the preceding chapters, i.e., Chapter VII, and Chapter VIII, may be sufficient cause for removal from office or suspension from membership or both using the grievance procedure.
- Section 2. If an elected officer or director absents himself for 3 consecutive meetings, general, and for Board meetings, except through work, sickness or absence from the area, his/her office may be declared vacant, and the Executive Board may proceed to filling said vacancy after written notification.
- Section 3. Any member who is intoxicated or uses profane language may be expelled from a meeting.

Chapter X

Official Paper

- Section 1. When the Executive Board may deem necessary, a Club paper, to be non-political, non-sectarian may be issued.

Chapter XI

Political Action

- Section 1. No member or members of this Club shall be allowed to use the name Allied Sportsmen of Western New York, Inc. for any political purpose to further their personal interests. Provided, that the Executive Board may recommend to the Club to take political action where its interests may be benefited thereby.

Chapter XII

Dissolution

- Section 1. This Club shall not have the power of dissolving itself while there are 15 dissenting members.

Chapter XIII

Amendments

- Section 1. These By-Laws may be amended by a vote of 2/3rds of the members present at any regular meeting. However, before any change is made, the proposed change must be referred to the Committee of Legislation for their consideration and re-drafting if they deem necessary.
- Section 2. The Committee of Legislation will report on any proposed changes at the second regular meeting after the meeting at which the proposed changes were made, or sooner if it deems necessary.

Allied Sportsmen of Western New York, Inc.

Rules Committee Meeting

1. **No Alcoholic** beverages past the door of the Club house.
2. **No Alcoholic** beverages on concrete pads and ready area while Trap fields are open.
3. **No Alcoholic** beverages on outdoor rifle range, pistol range, and ready areas.
4. **No Alcoholic** beverages on outdoor archery fields or indoor target areas.
5. **No Children** are allowed to sit at the bar.
6. **When the Bar is open** NYSLA rules prohibit the consumption of alcohol that has not been purchased at the bar.
7. **Bartenders** have full authority to refuse to serve a drink at the bar. The Club will not tolerate vulgar language, destruction of the Club property, or improper behavior. You will be asked to leave.
8. **All Handguns** in Club house, except on the indoor range, shall be holstered or cased.
9. **No Shouldering** or repairing firearms in the clubhouse except in these designated areas: Indoor range, Kitchen, and Gun Room.
10. **Outdoor Ranges** are open for firearm shooting during the following hours as defined by the Town of Marilla Range Law: Mondays, Tuesdays, Wednesdays 11 AM to 2 PM and 5 PM to 10 PM. Sundays 10 AM to 5 PM, in addition to nine (9) special events.
11. **Trap Houses** No persons under the age of 18 shall be allowed in the trap houses.
12. **Indoor Range** Ventilation system shall be used whenever the discharge of firearms is occurring.
13. **No Ammunition** except 22 cal. Rim fire is allowed on the outdoor rifle/pistol range. Shotgun slugs can be used only on scheduled sight in days just prior to the opening of shotgun season.
14. **Targets** Members shall use only paper or Board approved metallic targets.
15. **Eye Protection** is required for discharging firearms on any range.
16. **Ear Protection** is required for discharging firearms on any range. Pellet pistols are exempt unless intermixed with other firearm shooters.

17. **Action Open** No person shall go downrange until firearms are put down and actions are proven open.
18. **Hunting and Fishing** The club grounds and pond are available to all members for archery hunting and fishing (no guns). All New York State and DEC rules and regulations must be followed which includes being in possession of a valid hunting or fishing license. Catch and release barbless hooks at the pond please.
19. **No Ice Fishing** or skating is allowed on the pond.
20. **No Hand Throwers** are allowed on club property. Ground based mechanical throwers are allowed.
21. **Trap Loads** Maximum allowable trap load is 3 drams equivalent of gunpowder.
22. **No Outside** concern shall be allowed to use the Club property without prior Board approval.
23. **Club Facilities** shall not be used for personal gain.
24. **The Club House** and facilities should be left in better shape than you found it. Please clean up after yourself.
25. **If A Motorized** recreational vehicle is to be used, please confine its use to the club grounds.
26. **Outdoor Archery** range is open from sunrise to sunset. Leave range fee in envelope at mail slot at back door.
27. **No Broadheads** are to be used on the field targets.
28. **Last Person** exiting the club shall make sure the lights are out, thermostat is set to 55 degrees, bar is locked, windows are closed and locked, and alarm is set before exiting. Gate lock secured when not in winter plowing mode.
29. **Anything Unusual** should be reported to an officer or Board Director.
30. **Outdoor Fires** only in approved locations and must be extinguished when exiting grounds.
31. **The Above Rules** Are in supplement to the Constitution and By-Laws of Allied Sportsmen of Western New York, Inc. and are a supplement to the rules which may govern any shooting or social event held at Allied.
32. **The Calendar** shall be updated monthly.
33. **An Organizational Chart** shall be maintained accordingly.

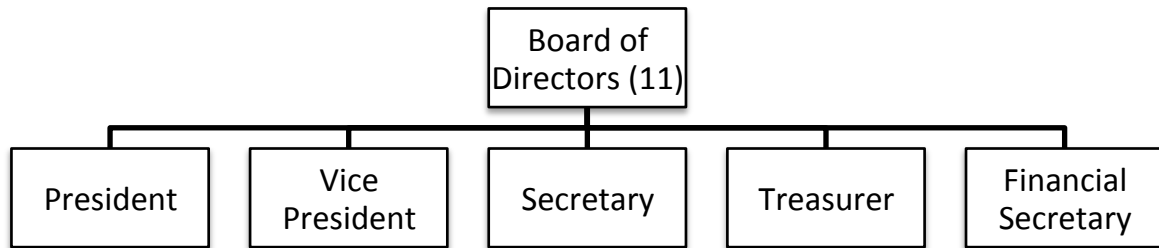
